DAVID J. FOWLER (GSNB '79, '87) is a consultant and researcher. He has worked as a project historian with Special Collections and University Archives at Rutgers University Libraries. In 2009 and 2010 he co-curated two exhibitions on Henry Rutgers, in conjunction with which he authored the biographical essay "Benevolent Patriot: Henry Rutgers, 1745–1830." She contributed an essay to Paul Clemens's Rutgers since 1945: A History of the State University of New Jersey, and she is presently writing a book on the architecture and social history of residence halls.
